Similar to articles of incorporation, articles of organization provide the basic information needed to register your company with the Texas Secretary of State. Purpose The purpose of your LLC must also be stated in your organization article. One is "pair value", which means there is a minimum dollar amount indicated for each share that will be issued. Also included with the name is the type of entity: for-profit, non-profit, professional association, limited liability company or other type of business. Business Licenses: Depending on the nature and location of your LLC, you may need to obtain local or local business licenses. Only a Texas resident or a corporate entity registered with the state can be appointed as a registered agent. Articles of Organization LLC Texas is a document that you must archive if you want to form a limited liability company (LLC) in Texas. In addition to the registered agent's name, you must include the agent's physical address in your organizational article. It has to be a physical address, not a P.O. box or a postal service. Creating an Operating Agreement Creating an operating agreement is not a requirement for LLC training in Texas, but is highly recommended. These requirements include: Employer Identification Number (EIN): If your LLC has employees or more than one member or you choose to pay taxes as a corporation, you must obtain an EIN from the IRS. Auditor of Public Accounts: If you are going to sell goods and collect sales tax, you must register with the State Auditor of Public Accounts.
