Purpose The purpose of your LLC must also be stated in your organization article. One is "par value", which means there is a minimum dollar amount indicated for each share that will be issued. Also included with the name is the type of entity: for-profit, non-profit, professional association, limited liability company or other type of business. Business Licenses: Depending on the nature and location of your LLC, you may need to obtain local or local business licenses. Also called the registered office, this address is the place where you can reach the registered agent during business hours. Creating an Operating Agreement Creating an operating agreement is not a requirement for LLC training in Texas, but is highly recommended. These requirements include: Employer Identification Number (EIN): If your LLC has employees or more than one member or you choose to pay taxes as a corporation, you must obtain an EIN from the IRS.
